**RE:** Cease and Desist Harassment

Tortfeasor,

We, Good Client; Complainant 1; Complainant 2; Complainant 3; Complainant 4; Complainant 5; Complainant 6; and Complainant 7 write this Cease and Desist Letter (hereinafter referred to as this “**Letter**”) in response to your constant phone calls and constant contact and harassment of us, and we hereby **DEMAND THAT THE HARRASSING PHONE CALLS AND OTHER FORMS OF CONTACT CEASE AND DESIST IMMEDIATELY!**

Pursuant to the laws of the State of Utah, you must **CEASE** and **DESIST** all communication with us after being notified in writing that we no longer wish to communicate with you. Therefore, we hereby demand that you stop calling us at our respective homes, at our respective work, on our respective cell phones, or at any other location or by any other method! Furthermore, **YOU MUST NOT, AND ARE HEREBY FORBIDDEN, FROM CONTACTING ANY OF OUR FRIENDS, FAMILY, OR EMPLOYERS—ESPECIALLY COMPLAINANT 1’S EMPLOYER, WHOM YOU HAVE ALREADY THREATENED TO CONTACT TO CAUSE HARM TO COMPLAINANT 1’S EMPLOYMENT!**

Furthermore, we know that you ran Good Client’s credit report, which is a federal offense. We hereby **DEMAND** that you **CEASE AND DESIST** from running *any* of our credit reports in any measure! If you do not abide by this demand, and if you continue running any of our respective credit reports, **WE WILL TAKE FEDERAL ACTION AGAINST YOU BECAUSE RUNNING SOMEBODY’S CREDIT REPORT UNAUTHORIZEDLY IS, AS AFOREMENTIONED, A FEDERAL OFFENSE!**

You are indubitably and persistently harassing us by your constant phone calls and messages regarding Complainant 1 and his termination of his relationship with you. You had a

purely online relationship with Complainant 1; you never met Complainant 1 in person, and your relationship with him only lasted five months. It is absurd and absolutely unbecoming of a reasonable person that, given the foregoing factors of your relationship with Complainant 1, you harass us with constant phone calls and messages. Complainant 1 decided to terminate his relationship with you, which he was entitled to do, and you must learn how to move on. It is unacceptable that you harass Complainant 1, as well as all of us, because he terminated his relationship with you. You have no legal or reasonable standing to continue harassing us, so you, therefore, **MUST CEASE AND DESIST ALL FORMS OF CONTACT WITH US IMMEDIATELY, OR WE WILL TAKE AGGRESSIVE LEGAL ACTION AGAINST YOU!**

Be advised that we are well aware of our rights! For instance, we know that any future contact by you subsequent to this letter would violate the laws of the State of Utah, and then we would be entitled to seek and apply aggressive legal remedies against you, such as placing a restraining order against you, or any other formal legal proceeding to cause the Court to compel you to cease and desist contact with us. Be aware that our potential litigation against you could likely result in hefty fines and even jailtime for you. For example, if you violate a duly granted restraining order which orders you to cease contact with us, we could—and would—file an order to show cause to compel you to show cause as to why you should not be jailed and fined for your violation of the restraining order. If you cannot show such cause—which you would not be able to show if you explicitly and directly violate the order—then hefty fines and jailtime would be applied against you by the Court. Is harassing us worth the potential fines and jailtime? We do not think so; we urge you to reconsider your actions.

Be advised that we are keeping accurate records of all correspondence, phone calls, and messages from you, including tape recording of any and all future phone calls from you. As aforementioned, if you continue calling us or otherwise contacting us, we will pursue aggressive legal action against you, including filing a federal complaint with our State Attorney General's Office. We have had it with your persistent phone calls! Our patience with you has expended, and, therefore, we are ***demanding*** that all phone calls from you cease and desist immediately from this date forward.
